CERTIFICATE OF WATER RIGHT

This Is to Certify, That RICHARD SPANGLER

of Route 1, Box 339, Forest Grove, State of Oregon ⁹⁷¹¹⁶, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of reservoir constructed under App. No. R-26220, Permit No. R-1232 a tributary of West Dairy Creek for the purpose of supplemental irrigation under Permit No. 20602 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 20, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 7.4 acre feet

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 3, Township 1 North, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ~~two and one-half acre feet per second~~ the equivalent to 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated in any one irrigation season and shall be further limited to a total of not to exceed 7.4 acre feet in any one irrigation season,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 10.5 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$
 - 35.0 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$
 - 2.8 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$
 - 28.9 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$
 - 22.6 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$
