CERTIFICATE OF WATER RIGHT

This Is to Certify, That JACK A. WRIGHT & SON

of Box 233, Lafayette , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Yamhill River a tributary of Willamette River for the purpose of

irrigation

under Permit No. 18795 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 23, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.46 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWINE, as projected within Fletcher DLC #60, Section 13, Township 4 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 7.0 acres in the SW1SE1 1.6 acres in the SE1SE1 Section 12 16.4 acres in the NW1NE1 11.6 acres in the NE1NE1 Section 13 Township 4: South, Range 4 West, W. M. All as projected within Fletcher DIC #46

Land on which water is to be used is part of that described as follows:

Beginning at the NW corner of the Francis Fletcher DLC in the Yamhill River; thence S. 0°11'41" W. 1583.41 ft. along the E. line of the Jacob Hawn DLC to a point in the Yamhill River; thence S. 89°22'16" E. 2822.53 ft.; thence N. 22°06'51" W. 925.66 ft.; thence N. 89°51'21" W. 591.30 ft.; thence N. 0°23'21" W. 758.67 ft. to the N. line of the Francis Fletcher DLC; thence S. 89°54'10" W. 1872.06 ft. along the N. line of the Francis Fletcher DLC to the point of beginning along the N. line of the Water for the purposes aforesaid is restricted to the Lands or place of use herein described.
