## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That CHRIS HANSEN

of Route 3, Box 16, McMinnville, , State of Oregon . , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Yamiill River

a tributary of Willamette River

for the purpose of

irrigation
under Permit No. 19011 of the State Ergineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from September 29, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.56 cubic foot per second .

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW SET, as projected within Martin DLC #83, Section 28, Township 4 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each mar,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 4.0 acres in the IEISW2, as projected within Ford DLC #73

6.0 acres in the SEISWI, as projected within Ford DLC #73 16.7 acres in the NWISEI, as projected within Ford DLC #73 29.0 acres in the SWISEI, as projected within Ford DLC #73 Section 28

11.6 acres in the NULNEL, as projected within Ford DLC #73
2.1 acres in the NELWA, as projected within Ford DLC #73
Section 33

Township 4 South, Range 4 West, W. M.

Land on which water is to be used is part of that described as follows:

Being a part of the E3 of the DLC 73 of Ephriam Ford & a part of the DLC 83 of
Nehamiah Martin, in T & S., R & W., W.M. Which said part thereof is more particularly
bounded & described as follows, to-wit: Beginning at a point being 44.05 chains E.

from the NW corner of said Ford D.C & 5.45 chains W. from angle corner in N. line of
said claim, & running thence S. 40.14 chains; thence E. 19.91 chains; thence N. 11

45° W. 15.66 chains; thence N. 23.80 chains to a point in center of the Yamhill R.;
thence N. 55° W. down center of said river 2.14 chains to a point in line with N.
boundary line of said Ford DLC; thence W. 12.50 chains to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
