CERTIFICATE OF WATER RIGHT

This Is to Certify, That OFEGON STATE GAME COMMISSION

of 1634 S. W. Alder St., Portland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Ana River a tributary of for the purpose of restoration of marshland for wildlife propagation under Permit No. 19131 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 9, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 60.00 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE\(\frac{1}{4}\)SE\(\frac{1}{4}\), Section 2\(\frac{1}{4}\), Township 30 South, Range 16 East, W. M., SE\(\frac{1}{4}\)SE\(\frac{1}{4}\), Section 17, Township 30 South, Range 17 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ---- of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

All that part of the bed of Summer Lake located in the following described sections lying within the meander lines as established by the United States Government Survey approved by the Surveyor General, January 13, 187h and April 15, 1876, to wit: Sections twenty-four (2h), twenty-five (25), twenty-six (26), thirty-five (35) & thirty-six (36), Township thirty (30) South, Range sixteen (16) East of the Willamette Meridan; Sections twenty-nine (29), thirty (30), thirty-one (31) and thirty-two (32), Township thirty (30) South, Range seventeen (17) East of the Willamette Meridian: Sections one (1) and two (2) and the North Half $(\frac{1}{2})$ of the North Half $(\frac{1}{2})$ of Section eleven (11) and twelve (12), Township thirty-one (31) South, Range sixteen (16) East of the Willamette Meridian; Sections four (h), five (5), & six (6) & the North Half $(\frac{1}{2})$ of the North Half $(\frac{1}{2})$ of Sections Seven (7), eight (8) and nine (9), Township thirty-one (31) South, Range seventeen (17) East of the Willamette Meridian, containing six thousand one hundred sixty-three and eighty-nine one-hundredths (6163.89)

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
