## CERTIFICATE OF WATER RIGHT

## This Is To Certify, That BRUCE CUNNINGHAM

State of , has made proof Drain Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Elk Creek

a tributary of Umpqua River for the purpose of

irrigation under Permit No. 19601 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 5, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.84 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWANEL & SELNEL, as projected within Putman DLC #39, Section 16, Township 22 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is

appurtenant, is as follows:

4.0 acres in the NEASWA 5.9 acres in Lot 4  $(NW_4^{1}SE_4^{1})$ 

14.1 acres in the NWISEI, as projected within Putman DLC #38

3.3 acres in Lot 7 (NE SE 4)

10.7 acres in the NE4SE4, as projected within J. Putman DLC #38

17.0 acres in the SWANEA, as projected within J. Putman DLC #38 5.8 acres in the SEANEA, as projected within C. Putman DLC #39 0.1 acres in Lot 8 (SEANEA)

19.5 acres in the SE4NE4, as projected within J. Putman DLC #38

2.2 acres in the NE 1 Re as projected within C. Putman DIC #39

4.3 acres in the NE NE4, as projected within J. Putman DLC #38 Section 16

Township 22 South, Range 6 West, W. M.

Land on which water is to be used is part of that described as follows:

Beginning 10 chains S. & 5.77 chains W. of the NE corner of Lot 7 in Sec. 16, T 22 S., R 6 W., W.M., thence running W. to the SW corner of the N2 of the NE4 SW4 of Sec. 16, thence N. 10.00 chains, thence E. to claim line of the Joseph Putnam DLC #38, thence N. on said claim line to corner of said claim, thence W. 8.20 chains to said claim corner, thence N. on said claim line to the old county road, thence Northeasterly along the old road to the intersection of Highway #38, thence following along the S. side of Rt/Way of said Highway in a Northeasterly direction to a point 5.77 chains due W. of the line between Sections 15 & 16, thence S. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
