CERTIFICATE OF WATER RIGHT

This Is to Certify, That MELVIN N. OBERG

of Route 2, Box 343 A, Forest Grove, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Gales Creek a tributary of Tualatin River for the purpose of irrigation

under Permit No. 20135 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 2, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Parson DLC #37, Section 31, Township 2 North, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 3.3 acres in Lot 4 (SW $\frac{1}{4}$ SW $\frac{1}{4}$)
11.8 acres in Lot 3 (SE $\frac{1}{4}$ SW $\frac{1}{4}$)
10.0 acres in the N $\frac{1}{2}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Parson DLC #37
0.9 acres in Lot 2 (SW $\frac{1}{4}$ SE $\frac{1}{4}$)

Section 31

Township 2 North, Range 4 West, W. M.

Land on which water is to be used is part of that described as follows:

All that part of the following described real property in Sec. 31, T. 2 N., R. 4 W., W. M., lying W. of a creek known as Trussell Creek, said creek being the only creek crossing said property: Beginning at a point on the N. line of the Omri Parsons DLC #37, in Sec. 31, T. 2 N., R. 4 W., W. M., said point being 1732.38 ft. W. of the NE corner of said DLC; thence N. 0°04' E. 429 ft., more or less, to a point on the N. line of Lot 2, Sec. 31, T. 2 N., R. 4 W., W. M.; thence W. to the NW corner of Lot 4 in said Sec. 31, T. 2 N., R. 4 W., thence S. to the SW corner of said Lot 4; thence E. along the N. line of the Parsons DLC to the place of beginning, excepting tract conveyed to the Gales Creek & Wilson River R. R. Co., by deed recorded at Page 1, Book 110, Deed Records of Washington County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
