## This Is to Certify, That FRED & ELLEN GILMORE

confirmed dates from December 5, 1950

of P. O. Box 933, Roseburg , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umoqua River a tributary of for the purpose of irrigation under Permit No. 20352 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (SE\frac{1}{4}SE\frac{1}{4}), Section 26, Township 27 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.73 acres in Lot 3 (SEASEA)
Section 26
0.12 acres in Lot 1 (NEANEA)
Section 35
Township 27 South, Range 6 West, W. M.

Land on which water is to be used is part of that described as follows:

North Tract - Beginning at a pipe on the Westerly right of way line of County Road #Ill, from which the SE corner of Lot 11 of "The Oaks" in Secs. 26 & 35, T 27 S., R 6 W., W. L., in Douglas County, Oregon boars S. 19°25' W. 80.1 ft., thence N. 65°04' W. 253.35 ft. to a pipe, thence continuing N. 65° 04' W. 177 ft. (1) to a point on the Easterly bank of the S. Umpoua River, thence Northeesterly along said river bank 86 ft. (1) to a point, thence S. 65°04' E. 124 ft. (2) to a pipe, thence continuing S. 65°04' E. 176.C ft. to a pipe, thence S. 65°04' E. 130.3 ft. to a pipe on the Westerly right of way line of County Road #Ill, thence S. 21°46' W. 85.13 ft. along said right of way line to the place of beginning, containing O.85 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
