CERTIFICATE OF WATER RIGHT

This Is to Certify, That curtis T. BRECHER & HARRY E. WILSON

of C. V. Route, Box 551, Roseburg, State of Cregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umpqua River

a tributary of Umpqua River irrigation

for the purpose of

under Permit No. 20402 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 26, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.11 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NTARE 1, Section 27, Township 28 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5 acres in the NULLY Section 27

Township 28 South, Range 6 West, W. M.

Land on which water is to be used is part of that described as follows:

Beginning at a point from which SW corner of Lot 18 Plat F Roseburg Home Orchard Tracts bears S. 368 ft. & W. 240 ft.; thence N. 160.0 ft.; thence S. 77°10' E. 789.2 ft. & 60.1 ft. to the E. boundary of said Lot 18, & the S. Umpqua River; thence S. 35°59' W. 169.6 ft. upstream along said river & E. boundary of said Lot 18; thence N. 77°10' W. 87.0 ft. & 566.0 ft. to the place of beginning; in said Lot 15, Roseburg Home Orchard Tracts & Sec. 27, T 28 S., R 6 W., W.M., Douglas County, Oregon. Beginning at a # iron pipe from which the SW corner of said Lot 18 bears S. 528 ft. & W. 240 ft.; thence N. 38.2 ft. to a 3/1" iron pipe in the N. boundary of said lot; thence S. 50°31' E. 224.6 ft. along the N. boundary of said lot & S. 82°00' E. 831.0 ft. & S. 82°00' E. 27.0 ft. to the NE corner of Lot 18 at the bank of the S. Umpqua River. Thence following the E. boundary of said Lot 18 & the S. Umpqua River upstream S. 35°59' N. 327.7 ft.; thence N. 77°10' W. 60.1 ft. & 789.2 ft. to the place of beginning containing 5.9 acres more or less in Lot 18 Plat F Roseburg Home Orchards Tracts & Sec. 27, T. 28 S., R. 6 W., W. M. in Douglas County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
