of record in the Record of Proceedings of said Board, at Salem, in Volume 1

at page 212 , on the 22nd day of January, 1919 ; that the priority of

the right hereby confirmed dates from July 1, 1915; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not

exceed 0.72 cubic feet per second, or its equivalent in case of rotation. The use hereunder shall conform to any reasonable rotation system ordered by the proper State Officer confirmed is appartenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 23.10 acres in the Southeast quarter of Northeast quarter; 6.81 acres in the Southwest quarter of Northeast quarter of Section Thirty-three; 22.10 acres in the Southwest quarter of Northwest quarter and 5.29 acres in the Southeast quarter of Northwest quarter of Township Thirty-six South, Range Two West of Willamette Meridian, in Jackson County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
