CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHAS. G. SMITH

of Route 2, Box 229, McMinnville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed spring, unnamed stream & reservoir constructed under App. No. R-23914, Permit No. R-1019 a tributary of N. Yamhill River for the purpose of irrigation under Permit No. 19427 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 13, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second, being 0.02 cfs from spring & 0.23 cfs from stream & reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW¹/₄SW¹/₄, & SE¹/₄SW¹/₄, Section 2, Township 4 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1019,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.0 acres in the SW¹/₄SW¹/₄
 23.4 acres in the SE¹/₄SW¹/₄
 Section 2
 Township 4 South, Range 5 West, W. M.

Land on which water is to be used is part of that described as follows:
 Also Lot 4 and the S¹/₂ of the SW¹/₄ of Section 2 in T. 4 S., R. 5 W., W. M., in Yamhill County, Oregon, excepting therefrom that part of said Lot 4 described as follows: Commencing at the NE corner of said Lot 4, run thence W. 3.26 chains, more or less, to the W. bank of Jowler Creek; thence S. to the S. line of said Lot 4, thence E. 3.274 chains to the SE corner of said Lot 4; thence N. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
