## CERTIFICATE OF WATER RIGHT

This Is to Certify, That FORREST C. TURNER

Uregon of Route 1, Box 187 A, Silverton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of , State of , has made proof umnamed stream & reservoir constructed under App. No. R-23666, Pcr. No. R-1085 for the purpose of a tributary of Beaver Creek, Tributary of Willamette River irrigation of the State Engineer, and that said right to the use of said waters under Permit No. 19911 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 30, 1919

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.21 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE1SW1, SW1SE1, as projected within Geor DIC #57, Section 18, Township 8 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year, from direct flow and storage from reservoir constructed under Permit No. R-1085,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 16.0 acres in the SW SE , as projected within Guer DLC #57 Section 18

0.8 acres in the NW NE , as projected within Geer DLC #57 Section 19

Township 8 South, Range 1 West, W. M.

Land on which water is to be used is part of that described as follows: Beginning at a point in the N. line of the Herman J. Geer DLC #51 in T. 8 S., R. 1 W., W. M., which point is 37.51 chains E. of the NW corner thereof, said point being also the NE corner of the 120 acre tract conveyed to Henry A. Keene by deed recorded in Vol. 68, page 333, Deed Records for Marion County, Oregon; thence S. along the E. line of said tract 53.33 chains; thence W. 37.51 chains to the W. line of said claim; thence W. on said W. line 39.61 chains to the most southerly SW corner of the 48.37 acre tract conveyed to J. L. Noyes by instrument recorded in Vol. 69, page 313, Deed Records for Marion County; thence N. 78° 115' 3. along the center of the County Road, 8.02 chains; thence N. 23° 30' E. along the center of said road to its intersection with the N. line of said Claim #51; thence D. on said line to the place of beginning.
