CERTIFICATE OF WATER RIGHT

This Is to Certify, That JEROME GEHRING

of Route 3, Box 99, Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Drift Creek a tributary of Pudding River for the purpose of irrigation under Permit No. 18707 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 28, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.13 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Blackerby DLC Cert. #307, Section 9, Township 7 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.4 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Blackerby DLC Cert. #307
Section 9
Township 7 South, Range 1 West, W. M.

Land on which water is to be used is part of that described as follows:

Commencing at a point in the center of a county road 59.75 chains S. & 5.08 chains W. of the N.E. corner of the W $\frac{1}{2}$ of the E $\frac{1}{2}$ of the DLC of the Joseph Blackerby & wife Not. No. 1 Cert. #307, in T. 7 S., R. 1 W., W. M. Thence N. 10.50 chains; thence N. 63°35' W. 5.20 chains, thence N. 75° W. 3.20 chains thence N. 80°12' W. 2.14 chains, thence N. 74°45' W. 3.57 chains, thence N. 52°48' W. 9.40 chains to the line of the C. F. Ames tract of land. Thence 21.10 chains to the center of county road. Thence along center of said road 20.80 chains to the place of beginning. Containing 33 acres of land more or less all situated in the aforesaid DLC Marion County.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
