CERTIFICATE OF WATER RIGHT

This Is to Certify, That ALAN OBERSINNER

of Route 2, Box 287, Woodburn, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Butte Creek a tributary of Pudding River for the purpose of irrigation under Permit No. 19089 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 19, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 SE 1/4, as projected within Chase DLC #11, Section 23, Township 5 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 2.4 acres in the SW 1/4 SE 1/4, as projected within Chase DLC #11
0.6 acres in the SE 1/4 SE 1/4, as projected within Chase DLC #11
Section 23
14.1 acres in the N 3/4 NW 1/4 NE 1/4, as projected within Chase DLC #11
12.9 acres in the N 3/4 NW 1/4 NE 1/4, as projected within Chase DLC #11
Section 26
Township 5 South, Range 1 West, W. M.

Land on which water is to be used is part of that described as follows: Being a fractional part of the DLC of Thomas J. Chase & Nancy Chase & described as part of Claim 46, T. 5 S., R. 1 W., W.M., Beginning at a point on Butte Creek on section line between Sec. 23 & 26 & 40 rods W. of the E. side of said sections; thence W. along said section line 30 rods to a ditch & fence; thence in a North-westerly direction 3 1/4 rods along a fence; thence S. 25° W. 26 rods to the section line, being the same as above; thence W. along said line 18 rods; thence S. 40 rods; thence W. 40 rods; thence S. 40 rods; thence E. 120 rods; thence N. 80 rods to the place of beginning, situated in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
