## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That J. H. DINSDALE

Route 1, Cornelius Oregon , State of , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualatin River Willamette River a tributary of for the purpose of irrigation 19665 under Permit No. of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 24, 1950 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.29 cubic foot per second or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SELSEL, as projected within C. Emerick DLC #48, Section 9, Township 1 South, Range 3 West, W. H. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 0.2 acres in the SWISEI, as projected within Geiger DLC #17

1.6 acres in the SWISEI, as projected within Emerick DLC #18

11.6 acres in Lot 1 (SWISEI)

5.8 acres in the SEISEE, as projected within Emerick DLC #18

9.0 acres in Lot 5 (SEISEI) Section 9 . 5.8 acres in the SW1SW1, as projected within Emerick DIC #48
Section 10 36.4 acres in the NEINE ? 29.6 acres in the NVINE ? Section 16 Township 1 South, Range 3 West, W. M. Land on which water is to be used is part of that described as follows: Let Tract: Commencing on the E. line of the DLC of Christian Emerick in Sec. 10, It S., R 3 W., W.M., at a point 5 chains N. of the SE corner of said claim; thence W. to the center of the Tuglatin R.; thence up said river with the meanderings thereof to the W. line of said DLC of C. Emerick; thence S. to the SW corner of said claim; thence E. to the SE corner of said claim; thence N. 5 chains to the place of beginning, containing 20 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of the service described.
