a tributary of Willamette River

for the purpose of

irrigation

under Permit No. 19936 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 12, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.07 cubic not per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SELSWL, as projected within Byrd DLC #75, Section 31, Township 2 South, Range 3 West, W. N.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth—of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of the to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 3.1 acres in the SF15N1, as projected within Byrd DLC #hl O.h acres in the SN15SE1, as projected within Byrd DLC #hl Section 3h

Township 2 South, Range 3 West, W. M.

1.0 acres in the NWANE', as projected within Byrd DLC #75

0.9 acres in the NEENWi, as projected within Byrd DLC #75

Township 3 South, Range 3 West, W. M. Land on which water is to be used is part of that described as follows: Being a part of the DLC of John Byrd & wife, Notification #4191 Claims #44 & 75 in T. 2 & 3 S., R 3 W., W.M., in Yarhill County, State of Oregon, said part being more particularly described as follows:

Regiming at a point 27.191 chains E. & 18.43 chains N. of the SW corner of said claim; thence running N. 11.00 chains; thence W. parallel to the S. line of said claim 8.729 chains; thence S. 11.00 chains; thence E. parallel to the S. line of said claim 8.729 chains to the place of beginning, containing 9.60 acres more or loss.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
