This Is to Certify, That FRANK W. BINDER

, State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Umpqua River

a tributary of irrigation

for the purpose of

20062 under Permit No. of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 4, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.7 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SW2NW2, as projected within Wells DLC #38,
Section 24, Township 22 South, Range 8 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 17 acres in the NW1NW2, as projected within Wells DLC #38

20 acres in the NE4NW2, as projected within Wells DLC #38

22 acres in the SE4NW2, as projected within Wells DLC #38

31 acres in the SE4NW2, as projected within Wells DLC #38

2 acros in the NE4SW4, as projected within Wells DLC #36

Section 24 Township 22 South, hange 8 West, W. M.

Land on which water is to be used is part of that described as follows:
