## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That ALVIN WEIRICH

of Route 1, Box 178, McMinnville , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Yambill Fiver

a tributary of Will

Willamette River

for the purpose of

irrigation

under Permit No. 20751 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 21, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4SE3, as projected within Carrison DLC #40, Section 5, Township 5 South, Range 4 West, W. IL

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres in the SWASWA Section 4
20.6 acres in the SEASEA Section 5
Township 5 South, Range 4 West, W. M. both as projected within Garrison DIC #40

Land on which water is to be used is part of that described as follows:
Sec. 5, T 5 S., R h W., W.M. Beginning at a point in center of Yamill River
20 chains W. of E. boundary line of W. J. Carrison claim running S. 17.25 chains
to stake on W. boundary line of Cooper lands, W. 18.50 chains to center of county
road now there. N. 8° E. 1h.75 chains to amile in Bennetts line. S. 82° E. 1
chain to angle in Bennetts line. N. 8° E. 5.50 chains to center of Yamill River.
Meandering down said Yamill River in center thereof to place of beginning.
Contains 30 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
