CERTIFICATE OF WATER RIGHT

This Is To Certify, That CON LYNCH
 c/o Forrest E. Cooper, Atty., Box 750, Lakeview, Oregon 97630 has made proof
 of Lakeview State of Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
 Hart Lake a tributary of Warner Lakes & streams for the purpose of
 supplemental irrigation under Permit No. 20854 of the State Engineer, and that said right to the use of said waters
 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
 confirmed dates from March 15, 1951.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
 aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
 28.0 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.
 The point of diversion is located in the #1 SW¹SW¹, #2 NE¹SW¹, Section 11, Township 36
 South, Range 24 East, W. M., #3 Lot 9 (SW¹SW¹), Section 18, Township 36 South,
 Range 25 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other
 right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second
 per acre, or its equivalent for each acre irrigated and shall be further limited
 to a diversion of not to exceed 3 acre feet per acre for each acre irrigated
 during the irrigation season of each year, provided further that the amount of
 water allowed herein, together with the amount secured under any other right
 existing for the same lands shall not exceed the limitation allowed herein.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
