CERTIFICATE OF WATER RIGHT

This Is to Certify, That M. SWARTZENTRUBER

of Route 1, Box 183, McKinville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Yamhill River a tributary of Willamette River for the purpose of irrigation under Permit No. 21888 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 17, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within Martin DLC #37, Section 5, Township 5 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.4 acres in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within Martin DLC #37
- 9.4 acres in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within Martin DLC #37
- 1.0 acres in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within Garrison DLC #40
- 7.2 acres in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within Martin DLC #37

Land on which water is to be used is part of that described as follows:

Beginning at the NW corner of W. J. Garrison DLC N. 80 $\frac{1}{4}$ ° E. (var. 20°45' E.) 33.85 chains S. 49.75 chains to N. bank of Salt Creek, thence westerly to point 33.61 chains S. of NW corner of Garrison claim, N. 33.61 chains to beginning.

Beginning at the SE corner of H. D. Martin DLC; S. 80°15' W. 26.63 chains, N. 1.50 chains to ct. of Yamhill River; down ct. main channel of S. Yamhill River to place where the N. & S. line of said claim crosses said river, S. 6.45 chains to place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
