that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually heneficially used for said purposes, and shall not exceed 0.17 cubic foot per second

has been perfected in accordance with the laws of Oregon; that the priority of the right hereby

The point of diversion is located in the NH SE4, as projected within Jones DLC #hh,

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1292,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.1 acres in the SWNE2
2.3 acres in the SE1W4
0.9 acres in the NE4SW4
2.0 acres in the NW4SE2
all as projected within Jones DIC #hh
