CERTIFICATE OF WATER RIGHT

This Is to Certify, That ALBERT W. BOCHSLER

of Route 1, Mt. Angel, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pudding River a tributary of for the purpose of irrigation under Permit No. 16991 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 7, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 & SE 1/4, as projected within Coonse DLC #62, Section 6, Township 6 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 16.1 acres in the SW 1/4, as projected within Felix Coonse DLC #62
0.3 acres in the SE 1/4, as projected within Felix Coonse DLC #62
1.8 acres in the SE 1/4 NW 1/4, as projected within Felix Coonse DLC #62
Section 6

Township 6 South, Range 1 West, W. M.

Land on which water is to be used is part of that described as follows:

Beginning at the 1/4 section corner between Sec. 1 & 6 in T. 6 & 1 range line between R. 1 & 2 W. & running thence E. 46.25 chains to Pudding River; thence N. 31° E. 1.00 chain; thence N. 64° E. 2.12 chains; thence N. 40° E. 1.45 chains; thence S. 71° E. 4.50 chains; thence S. 10° W. 1.99 chains to the line of said claim; thence E. 7.32 chains to Pudding River; thence N. 23 1/2° W. 18.50 chains; thence W. 56.77 chains to the W. boundary of the Coonse DLC, thence S. 16.97 chains to the place of beginning & containing 100 acres more or less & being in T. 6 S., R. 1 W., W. M., in Marion County, State of Oregon, & being in the land claim (in the SW corner thereof) entered under the Donation Act by Felix Coonse & wife, the said E 1/2 containing 50 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
