CERTIFICATE OF WATER RIGHT

This Is to Certify, That MRS. ETTA GOSSER

of Route 2, Box 140, Wolalla , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Wolalla River

a tributary of Willamstte Piver irrigation

for the purpose of

under Permit No. 17843 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 8, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.35 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWINNIA, as projected within Jackson BLC #45, Section 34, Township 4 South, Range 2 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toons—nightieth of one cubic foot per second per acres its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 23 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows 0 acre in the SETTET, as projected within Jackson DLC #45

10.4 acres in the NEISET, as projected within Jackson DLC #45

Section 33

11.6 acres in the SWINWI, as projected within Jackson DLC #15

11.6 acres in the NWISWI, as projected within Jackson DLC #1.5

Section 34

Township h South, Range 2 East, W. M. Land on which water is to be used is part of that described as follows:
Beginning at a point S. hh 30' W. 1901.3 ft. & thence S. h9 h9' E. 19h5.8 ft. from the most northerly corner of Jackson DLC h5, thence N. h9 h9' W. 925 ft., thence N. hh 21' E. parallel with said division line 1827.35 ft. to an iron pipe on the most northeasterly boundary of said DLC said iron pipe being N. h5 30' W. 922.60. ft. distant from a point of intersection of the division line of said DLC with the most northeasterly boundary thereof; thence S. h5 30' E. 922.60 ft. to the said division line; thence S. hh 21' W. along said division line 1760.1 ft. to the place of beginning, subject to public roads, the land hereby conveyed containing 36 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
