of Elsie Route, Jewell , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Wehalem River

a tributary of irrigation

for the purpose of

under Permit No. 18982 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 13, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.35 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (SWASWA), Section 33, Township 5 North, Range 7 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acres in Lot 3 (NE SE 1)

0.1 ccre in Lot 4 (SE 15)

Section 32. 8.8 acres in the NW15U12 15.6 acres in Lot 1 (SW15W1)

Section 33 Township 5 North, Range 7 West, W. M.

I and on which water is to be used is part of that described as follows:
Parcel No. 1 Lots numbered 3 & h Sec. 32, T 5 N., R 7 W., W.N., in the County of Clatsop, State of Oregon.

Parcel No. 2 The NWA of the SWA & Lot numbered 1, Sec. 33, T 5 N., R 7 W., W.M., excepting, however, from said Lot 1, the following: Beginning at the SE corner of said Lot 1; thence W. on section line 268 ft. to the E. side of County Poad No. 155; thence N. 150 ft. along the E. side of said County Road; thence northeastraly along the E. side of said road to a point 700 ft. N. of point of beginning; thence S. 700 ft. along the E. line of said Lot 1 to point of beginning. All being situate in the County of Clatsop, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
