## CERTIFICATE OF WATER RIGHT

This Is to Certify, That HORA AROLYN JAMES

of Yoncalla, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Elk Creek a tributary of Umpqua River for the purpose of irrigation under Permit No. 19748 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 2, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.27 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ , Section 14, Township 22 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.6 acre in the NE $\frac{1}{4}$ NW $\frac{1}{4}$   
21.4 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$   
2.0 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$   
3.0 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$   
Section 14

Township 22 South, Range 6 West, W. M.

Land on which water is to be used is part of that described as follows: Beginning at a point from which the SE corner of the NW $\frac{1}{4}$  of Sec. 14, T. 22 S., R. 6 W., W.M., bears E. 50.0 rods & running thence N. 1427.0 ft. to an intersection with the southerly r/w line of State Highway #38. Thence running in a northeasterly direction & along the said southerly r/w line 1027.7 ft. to an iron pipe from which the NW corner of the said Sec. 14 bears N. 75°02' W. 2804.3 ft. Thence leaving said State Highway & running S. 38°22' E. 138.9 ft. to an iron pipe; thence N. 70°34' E. 296.5 ft. to an iron pipe on the W. bank of Elk Creek from which a 36" Fir Tree bears N. 25°00' E. 3.0 ft. Thence continuing N. 70°34' E. 95.0 ft. to the center of Elk Creek. Thence following the center of Elk Creek downstream & in a southwesterly direction to a point S. of the place of beginning. Thence N. 365.0 ft. more or less to the place of beginning. The above described tract of land being situated in & being a part of Sec. 14, T. 22 S., R. 6 W., W. M., in Douglas County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
