a tributary of Umpqua River irrigation

for the purpose of

under Permit No. 20130 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 26, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.53 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SELSEL, as projected within Applegate DLC #38, Section 21, Township 22 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.0 acres in the Swissi, as projected within Applegate DLC #38 16.4 acres in the SEISEI, as projected within Applegate DIC #38 Section 21

1.8 acres in the SW2SW4, as projected within Applegate DLC #38 Section 22

19.1 acres in the METNET, as projected within Applegate DLC #38 0.1 acres in Lot 9 (NETNET)

1.0 acres in the NW1NE1, as projected within Applegate DLC #38 Section 28

Township 22 South, Range 5 West, W. M. Land on which water is to be used is part of that described as follows: TRACT FIVE: All that part of the N2 of the Jesse Applegate DLC, known in the public survey as claim #38, Not. #542, T. 22 S., R. 5 W., W.M., lying S. of a line starting at a point in the W. boundary of said claim 37.15 chains from the NW corner thereof & running parallel with the N. boundary of said claim to an intersection with the E. boundary of said claim, containing 121.0 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of

use herein described.
