State of , has made proof Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Elk Creek

a tributary of ... Umpqua River

for the purpose of

irrigation of the State Engineer, and that said right to the use of said waters under Permit No. 20160 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 3, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.53 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW1SW1, as projected within Daisley DLC #37, Section 8, Township 22 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.3 acres in Lot 7 (SW4SW4)
13.6 acres in the SW4SW4, as projected within Daisley DLC #37 4.8 acres in the SEASWA, as projected within Daisley DLC #37

Daisley DLC #37, T225., R6W, W.W., from which the sec. corner common to Sec. 7,8;17, & 18 bears S. 87°57' W. 363.6 ft. thence S. 61°46' E. 1093.9 ft. along the S. boundary of said DLC #37, thence N. 24° h3' E. 1131.6 ft. to a point in the center of Elk Creek S. 21 13' W. 112.0 ft. thence 67°10' W. 1092.2 ft. along the center of Elk Cr. thence S. 21°13' W. 1019.0 ft. to the place of beginning. AISO: Lot 1 Sec. 17, T22S., R6W., in Douglas County. Oregon.
