under Permit No. 20217 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 11, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.45 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE ISW 1, as projected within Townsend Not. 876, Section 21, Township 5 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

20.4 acres in the SE SW 1 15.2 acres in the SW SE 1 both as projected within 0.0. Townsend Not. 876 Section 21

Township 5 South, Range 1 West, W. M.

Land on which water is to be used is part of that described as follows:

Beginning at a point 5.50 chains N. of the $\frac{1}{4}$ sec. corner between Sec. 21 & 28 in T. 5 S., R. 1 W., W.M.; thence E. 14.63 chains to a point 30 ft. W. of the center of Main Line of the Springfield Branch of the Southern Pacific R. R.; thence N. 10° W. & parallel with said railroad 12.18 chains; thence W. 32.51 chains to the W. boundary of the DLC of Gamaliel G. Townsend & wife; thence S. 12.10 chains; thence E. to the place of beginning, & containing 40 acres of land more or less, being a part of the DLC of Gamaliel G. Townsend & wife, Not. 876 & a part of Sec. 21 of said township & range, all in Marion County & State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
