This Is to Certify, That ARTHUR B. & RUTH A. KAYSER

of Route 2, Box 113, Wolalla , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a channel of the Molalla River

a tributary of Willamette River

for the purpose of

irrigation

under Permit No. 16108 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 28, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SW4SW4, Section 2, SE4SE4, Section 3, Township

5 South, Range 2 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acrepr its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.0 acres in the SW4SW4

Section 2 18.0 acres in the SE4SE4 Section 3

0.2 acres in the NETNET Section 10

Township 5 South, Range 2 East, W. M.

Land on which water is to be used is part of that described as follows:

Beginning at a stone 158.15 ft. S. & 262.92 ft. W. of the SE corner of Sec. 3, in T 5 S., F. 2 E., W.M., & running N. hl hl hl w. 1831.8h ft. to a stone in the road on the S. line of the Wm. H. Vaughan DLC #17, thence N. hh E. along said claim line 172.92 ft. to a stone at the forks of the road; thence S. 88 51' E. 1992.00 ft. to a stone; thence S. 13 01' W. 1100 ft. to a stone; thence S. 59 h6' W. 716.2 ft. to the point of beginning, containing hh acres more or less. Except 7.80 acres along the SW side conveyed to Marvin Lester Miller & Aletha Miller, His wife, by deed recorded Aug. 14, 1931, in book 212 of deeds page 388, & except 0.9348 acres in the NE corner conveyed to Clackamas County, by deed recorded Nov. 25, 1941 in book 287 of deeds page 600, & except the rights of the public in and to public roads.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
