of P. O. Box 203, Yamhill , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream

a tributary of N. Yamhill River

for the purpose of

irrigation

under Permit No. 19523 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 29, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SWANWA & NWANWA, as projected within T. Davis
DLC #12, Section 1, Township 3 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.1 acres in the NW4NW4 0.9 acres in the SW4NW4 Section 4

Township 3 South, Range 4 West, W. M. both as projected within T. Davis DLC #42

Lend on which water is to be used is part of that described as follows:

Sec. 4, T. 3 S., R. 4 W., W.M. Part of T. C. Davis DLC. Beginning in center of county road at a point 28.21 chains S. & 9.75 chains W. of NE corner said DLC; thence N. 4 W. 9.92 chains; thence N. 89½, W. 8.02 chains; thence S. 3/4 W. 9.87 chains to center of county road. Thence S. 89° 25 ft., E. 8.16 chains to beginning. Containing 8 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
