**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** PHILIP G. WILSON

of Route 1, Dundee, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Hess Creek a tributary of Willamette River for the purpose of irrigation under Permit No. 19715 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 24, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.12 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ , Section 34, Township 3 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.2 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$   
6.8 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$   
Section 34

Township 3 South, Range 3 West, W. M.

Land on which water is to be used is part of that described as follows:

From an iron pipe planted at the intersection of the N. boundary of the Edward R. Geary DLG with the boundary between Sec. 34 & 35, in T. 3 S., R. 3 W., W.M., running thence N. 89°36' W. tracing said N. boundary of said DLG 1584.46 ft., & thence N. 0°5' W. 1361.68 ft. for the place of beginning; thence N. 0°5' W. tracing W. boundary of a tract of land deeded by William Forbes to Ashnah J. Vedder by a deed recorded in Book 68, page 452, Deed Records of Yamhill County, Oregon, 1303.86 ft. to a stake at the NW corner of said Vedder tract; thence N. 89°35' E. tracing the N. boundary of said Vedder tract 766.44 ft. to a point; thence S. 0°5' E. parallel to the W. boundary of said Vedder tract 1310.49 ft. to a point; thence S. 89°55' W. 766.44 ft. to the place of beginning, containing 23 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
