CERTIFICATE OF WATER RIGHT

This Is to Certify, That C. L. SANDERSON

of Route 1, Box 169, Rickreall, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rickreall Creek a tributary of Willamette River for the purpose of irrigation under Permit No. 21386 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 19, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Samuel Burch DLC #47, Section 29, Township 7 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 1.0 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Burch DLC #47 Section 29

Township 7 South, Range 4 West, W. M.

Land on which water is to be used is part of that described as follows: Beginning at an iron pipe on the S. line of the Salem-Dallas Hwy. at a point 433.0 ft. S. & 413.6 ft. N.84°49'E. & 1949.34 ft. N.85°43 3/4'E. from the NW corner of the S. Burch DLC #47 in T.7S., R.4W., W.M., in Polk County, Ore.; & running thence S. 264.5 ft. to a point in the center of the LaCreole Creek; thence N. 54°20 $\frac{1}{2}$ ' E. 122.73 ft.; thence N.200.4 ft. to an iron pipe on the S. line of said hwy.; thence S.85° 43 3/4' W.100.0 ft. to the place of beginning & containing 0.532 acres, more or less. ALSO: Beginning at the NE corner of above described property & running thence N. 85° 43 3/4' E. 174.64 ft. along the S. line of said hwy. to an iron pipe; thence along the arc of a 1402.5 ft. radius curve to the right (the long chord of which bears N. 86°41 3/4' E. 47.37 ft.) to a point on the S. line of said hwy.; thence S. 68.3 ft. to the approximate center of the LaCreole Creek; thence S. 64°35' W. 52.36 ft.; thence S. 54°15' W. 214.63 ft.; thence N. 200.4 ft. to the place of beginning, & containing 0.512 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
