CERTIFICATE OF WATER RIGHT

This Is to Certify, That CECIL E. HINES

of Route 2, Box 135, Cornelius , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Tualatin River

a tributary of Willamette River

for the purpose of

irrigation
under Permit No. 22591 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from August 25, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.20 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $SW_{3}^{1}SE_{3}^{1}$, Section 8, Township 1 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15.8 acres in the SW3SE3

0.1 acres in the SEASE4

Section 8

Township 1 South, Range 3 West, W. M.

Land on which water is to be used is part of that described as follows:

Beginning at the NE corner of the SE2 of the SE2 of said Sec. 8, T. 1 S., R. 3
W., W.M., & running thence W. 100 rods; thence S.77°h0' W. 652 rods; thence S.
66 rods to the section line; thence E. 164 rods; more or less to the SE corner
of said Sec. 8; thence N. 80 rods to the place of beginning.

EXCEPTING, however, the following tract: Beginning at a point on the E. line
of Sec. 8 in T. 1 S., R. 3 W., W.M., said point being N. 80 rods from the SE
corner of said section, running thence W. 1309 ft. to a point on the right bank
of Tualatin River; thence S. 1304 ft. to a point 16 ft. N. of an iron set on the
S. line of Sec. 8, said iron being W. 1309 ft. from the SE corner of Sec. 8; thence
E. & parallel with said S. line 1309 ft. to a point on the E. line of said Sec. 8;
thence N. 1304 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
