CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That HARRIETT L. VEAZIE, 745 Overton Street of Portland State of Oregon has a right to the use of the waters of Hay Creek, a tributary of Trout Creek and Wilson Creek, a tributary of Hay Creek

for the purpose of the irrigation of 359.35 acres of land, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jefferson County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 4 at page 57 ; that the priority of the right hereby confirmed dates from 1885 for Tract No. 1; 1907 for Tract No. 2 and 1886 for Tract No. 3

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.00 acre foot per acre during any period of 30 days or 3 acre feet per acre during any irrigation season, and shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

Tract No. 1 from Hay Creek: 7.25 acres in the SW 1/4 SE 1/4 and 13 acres in the SE 1/4 SE 1/4 of Section 30; 1 acre in the SE 1/4 SE 1/4; 37.25 acres in the SW 1/4 SE 1/4; 36 acres in the NW 1/4 SE 1/4; 15 acres in the SW 1/4 NE 1/4 and 22.25 acres in the NW 1/4 NE 1/4 of Section 31, T 9 S. R. 15 E. W. M., 9.25 acres in the NE 1/4 SE 1/4; 22 acres in the SE 1/4 NE 1/4; 13.50 acres in the SW 1/4 NE 1/4; 12.25 acres in the NE 1/4 NE 1/4 and 29.25 acres in the NW 1/4 NE 1/4 of Section 6, T 10 S. R. 15 E. W. M., in Jefferson County, Oregon. Tract No. 2 from Hay Creek: 2.50 acres in the NE 1/4 SE 1/4 of Section 30, T 9 S. R. 15 E. W. M., in Jefferson County, Oregon. Tract No. 3 from Wilson Creek: 15 acres in the SE 1/4 SE 1/4 of Section 30; 7 acres in the SW 1/4 NE 1/4; 11.25 acres in the SE 1/4 NE 1/4; 13.25 acres in the NE 1/4 NE 1/4; 15.50 acres in the NE 1/4 SE 1/4 and 19 acres in the SE 1/4 SE 1/4 of Section 31; 3.6 acres in the SW 1/4 SW 1/4 of Section 32, T 9 S. R. 15 E. W. M., 20.75 acres in the NW 1/4 NW 1/4; 5.50 acres in the SW 1/4 NW 1/4 and 26 acres in the NE 1/4 SW 1/4 of Section 5, T 10 S. R. 15 E. W. M., in Jefferson County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
