CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. E. BEELER

of Warren, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed creek a tributary of Scappoose Bay, tributary of Columbia River for the purpose of irrigation

under Permit No. 19975 of the State Engineer; and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 27, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Foster DLC #49, Section 20, Township 4 North, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.2 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$

Section 19

0.2 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$

Section 20

Township 4 North, Range 1 West, W. M.

both as projected within Foster DLC #49

Land on which water is to be used is part of that described as follows: Bega. at a point on the N. line of the Garner Foster DLC in Sec. 19, T 4 N., R 1 W., W.M., Columbia County, Ore.; said point being E. 5671.6 ft. from the NW corner of the said G. Foster DLC & also E. 78.0 ft. from the intersection of the N. line of the Foster DLC with the easterly r/w line of the St. Helens-Warren County Rd.; thence S. 22°21' W. 69.0 ft.; thence N. 69°37' W. 75.0 ft. to the easterly r/w line of the above said Cty. Rd.; thence along said easterly r/w line S. 26°11' W. 202.4 ft.; thence S. 82°21' E. 924.9 ft.; thence N. 19°06' E. 362.3 ft. to the N. line of the said G. Foster DLC; thence along said N. line W. 849.4 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
