CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That REX E. BORD  
of Olene State of Oregon has a right to the use of  
the waters of Lost River, a tributary of Tule Lake

for the purpose of the irrigation of 251 acres of land, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Klamath County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 41, 5, at page 94 ; that the priority of the right hereby confirmed dates from 1886 for 175 acres and from 1902 for 76 acres

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.14 sec. ft. during any irrigation season, and a quantity for domestic and stock purposes outside of the irrigation season at the rate of one-half second foot for each 1000 head of stock; and shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 10 acres in the SW 1/4 SE 1/4; 11 acres in the SE 1/4 SE 1/4 of Section 2; 24 acres in the NE 1/4 NE 1/4; 10 1/2 acres in the NW 1/4 NE 1/4; 26 acres in the SE 1/4 NE 1/4; 24 1/2 acres in the NE 1/4 SE 1/4; 1 acre in the SE 1/4 SE 1/4 of Section 11; 33 acres in the SW 1/4 NW 1/4; 33 acres in the NE 1/4 SW 1/4; 32 acres in the NW 1/4 SW 1/4; 11 acres in the SW 1/4 SW 1/4 and 35 acres in the SE 1/4 SW 1/4 of Section 12, T 39 S. R. 10 E. W. M., in Klamath County, Oregon.
