CERTIFICATE OF WATER RIGHT

This Is to Certify, That HERBERT E. & ELIZABETH B. HUNTER

of Route 3, Box 975, Albany, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Oak Creek a tributary of Calapooya River for the purpose of irrigation under Permit No. 23839 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 29, 1955

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Hutchins DLC #85, Section 13, Township 11 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.1 acre in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Hutchins DLC #85
Section 13
Township 11 South, Range 4 West, W. M.

Land on which water is to be used is part of that described as follows:

Beg. at a 3/4" Bolt N. 89°22' W. 149.27 ft. from the NW corner of Tract 15, of Calapooya Acres in Sec. 13, T 11 S., R 4 W., W. M., in Linn county, Ore., said place of beginning being also S. 89°22' E. from a point on the W. line of & S. 42.65 chains from the NW corner of the Issac Hutchins DLC #85 in said township & range; & running thence N. 89°22' W. 150.0 ft.; thence S. 0°38' W. 347.84 ft. to the center line of Oak Creek; thence up the centerline of Oak Creek as follows: S. 69°20' E. 58.15 ft., S. 58°15' E. 240.00 ft. & S. 21°45' E. 102.39 ft. to the W. line of tract 16 in Calapooya Acres; thence N. 0°38' E. 288.50 ft. to a 1/2" bolt; thence N. 89°22' W. 100.0 ft. to a 5/8" rod; thence N. 40°22' W. 158.40 ft. to a 3/4" bolt; thence N. 17°43' E. 186.64 ft. to the place of beg. & containing 1.82 acres more or less. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
