CERTIFICATE OF WATER RIGHT

This Is to Certify, That JAMES A. CHAF

of Myrtle Creek, , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Lyrtle Creek a tributary of South Umpqua for the purpose of irrigation under Permit No. 19091 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon at the priority of the right hereby confirmed dates from September 9, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.08 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NVLSEL Section 22, Township 29 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{3}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.8 acres in the NW\(\frac{1}{4}\)Section 22

Township 29 South, Range 5 West, W. M.

Land on which water is to be used is part of that described as follows:

Beg. at a point 1575.9 ft. N. & 516.5 ft. E. of the S\(^1_4\) corner of Sec. 22, T. 29 S.,

R. 5 W., W.M., thence N. 29°57' E. along the center line of the North Myrtle Creek

Rd. 523.3 ft.; thence N. 22°31' E. along the center line of said road 139.9 ft.;

thence S. 68°29' E. 20.0 ft.; thence S. 68°29' E. 153.85 ft.; thence N. 21°31' E.

26.1 ft.; thence S. 81°22°30" E. 230.11 ft. to the center of North Myrtle Creek;

thence along the center line of said creek S. 1°12' E. 278.08 ft.; S. 3°25'30" E.

121.1 ft.; S. 12°51' W. 121.98 ft.; thence N. 89°01' W. a distance of 701.59 ft.

to the place of beginning containing 7.07 acres more or less. Douglas County, Ore.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
