## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That J. B. THIFORD

of Route 2, Box 148, Hillsboro, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Artificial Drainage Ditch

a tributary of

Tualatin River

for the purpose of

irrigation

under Permit No. 18859 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 17, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$ ), Section 8, Township 2 South, Range 2 West, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

11.5 acres in Lot 1 (NE TWE )
Section 8

0.5 acres in Lot 1 (NWINWI)

Section 9

Township 2 South, Range 2 West, W. M.

Land on which water is to be used is part of that described as follows:

Beginning at a point 20 chains N. & 27 chains E. of the center of Sec. 8, T. 2 S., R. 2 W., W.M., running thence E. to a point in the center of Drainage Ditch; running thence northeasterly in the center of said ditch to the S. line of the Arthur Burris Claim No. 42, said point being 2 chains E. of the section line between Sec. 8 & 9, said township & range; running thence W. 2 chains to said section line; running thence S. 89°15' W. 13 chains; thence S. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use he ein described.
