a tributary of Tualatin River

for the purpose of

irrigation

under Permit No. 19304 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 16, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.13 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEINWI as projected within Ben Cornelius, Jr. DIC #42, Section 9, Township 1 North, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acrepr its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.1 acres in the NE₄NE₄, as projected within Harris DIC #55 8.8 acres in the NW4NE₄, as projected within Harris DIC #55 11.1 acres in the SW4NE₄, as projected within Harris DIC #55

19.4 acres in the SEANEA, as projected within Harris DIC #55 Section 8

2.8 acres in the NEANWA, as projected within Harris DLC #55

0.9 acres in the NETWIA, as projected within Cornelius DIC #42 12.7 acres in the NWINWI, as projected within Harris DLC #55

28.3 acres in the SW4NW4, as projected within Harris DLC #55

5.1 acres in the SEANWA, as projected within Harris DLC #55

3.4 acres in the SEINWI, as projected within Cornelius DLC #42 Section 9 11 36
