CERTIFICATE OF WATER RIGHT

This Is to Certify, That **JAMES McNULTY**

of Route 1, Box 171, Hubbard, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of 3 unnamed springs and Brandy Creek a tributary of Pudding River for the purpose of irrigation under Permit No. 19549 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 7, 1950 for 0.25 cfs July 13, 1950 for 0.04 cfs; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.29 cubic foot per second, being 0.15 cfs from creek and 0.14 cfs from springs.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Dimmick DLC #64, Section 35, Township 4 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.2 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$
22.4 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 35.

Township 4 South, Range 1 West, W. M.
both as projected within A. Dimmick DLC #64

Land on which water is to be used is part of that described as follows:

Beg. at a point in the N. boundary line of the A.R. Dimmick DLC, 30.57 chains E. of the NW corner of said claim; thence S. 1°6' W., 40.19 chains; thence W. 15.93 chains; thence N. 1°6' E. 24.30 chains; thence E. 15.63 chains; thence N. 1°6' E. 16 chains; thence E. .30 chain to the place of beg., situated in Sec. 35, T. 4 S., R. 1 W., W.M., in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
