CERTIFICATE OF WATER RIGHT

This Is to Certify, That . L. R. LYNAM

of Terrebonne , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well situated near Crooked River

a tributary of Deschutes River

for the purpose of

irrigation

under Permit No. U-153 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from kay 8, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/30th cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SENET, Section 36, Township 14, South, Range 15

East, N. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acres in the SEANE A
1.0 acres in the SWANE A
0.2 acres in the NEASE A
Section 36.

Township 14 South, Range 15 East, W. M.

Land on which water is to be used is part of that described as follows:

Beg. at a point on the southerly r/w line of the Warm Spring Highway as it is now located & constructed said point being 1793 ft. S. & 895 ft. E. of the N½ corner of said Sec. 36; thence S. 17°22' W. a distance of 175 ft. to a point on the northerly bank of Grocked River; thence S. 63°21' E. along said northerly river bank a distance of 360 ft.; thence S. 18°36' E. along said northerly river bank a distance of 565 ft. to the SW corner of the SE4 of NE4 of said Sec. 36; thence S. a distance of 197 ft. to a point; thence N. 17°22' E. a distance of 582 ft. to a point on the southerly r/w line of said Warm Springs Highway; thence N. 12°38' W. along the said r/w line a distance of 1038 ft. more or less to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
