CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHRISTENSEN BROTHERS

of Route 5, Hillsboro, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Christensen Creek a tributary of Tualatin River for the purpose of irrigation under Permit No. 17409 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 29, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.70 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4, Section 5, Township 2 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 28.2 acres in the SW 1/4 NE 1/4
  - 29.8 acres in the SE 1/4 NE 1/4
- Section 6  
Township 2 South, Range 2 West, W. M.

Land on which water is to be used is part of that described as follows:

All of the S 1/2 of the NE 1/4 of Sec. 6, T. 2 S., R. 2 W., W.M., Washington County, Ore. ALSO the following described tract of land: Beg. at the SE corner of the NE 1/4 of the NE 1/4 of Sec. 6, T. 2 S., R. 2 W., W.M., Washington County, Ore., & running thence N. on the E. line of said Sec. 6 26 rods to the SE corner of land heretofore sold & conveyed to Frank O. Erickson; thence W. on the S. line of said Erickson's land 36 rods to the SW corner of the land of Frank O. Erickson; thence S. on a line parallel with the E. line of said Sec. 6, 26 rods to the N. line of the S 1/2 of the NE 1/4 of said Sec. 6, T. 2 S., R. 2 W., W.M., county & state aforesaid; thence E. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
