CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROY & MAY MILLIGAN

of Route 1, Box 239 A, Clackamas , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Clackamas River

a tributary of Willamette River

for the purpose of

irrigation & fire protection under Permit No. 19023 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 6, 1949.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second, being 0.02 c.f.s. for irrigation & 0.01 c.f.s. for fire protection

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the Lot 3 (SE4SW4), Section 17, Township 2 South.

Range 3 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited tone-eightieth of one cubic foot per second per acreor its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.6 acres and fire protection in Lot 3 (SE4SW4)
Section 17
Township 2 South, Range 3 East, W.M.

Land on which water is to be used is part of that described as follows:
Commencing at a stone set for the \$\frac{1}{4}\$ section corner between sections 17 & 20 T 2 S,
R 3 E, W.M. & running thence W. 1100 Ft. to an iron pipe; thence N. 220 ft. to the
beg. of the area to be irrigated. From said place of beg., 260 ft. N.; thence 20 ft.
E.; thence 205 ft. N. to the N. boundary of area; from NE corner W 200 ft. more or
less to Clackamas River; thence Southerly & upstream along the Clackamas River 465
ft. more or less to a point which is W. of the above described place of beg.; thence
E. 160 ft. more or less to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
