of 4500 S.E. Glen Echo, Milwaukie , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River

for the purpose of

irrigation

under Permit No. 20804 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 5. 1951.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW4SW4, as projected within Rinearson DLC #41,
Section 19, Township 2 South, Range 2 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.3 acres in the NW4SW4, as projected within Rinearson DLC #41
- 0.3 acres in the SwiNWi. as projected within Rinearson DLC #41
 Section 19

Township 2 South, Range 2 East, W.M.

Land on which water is to be used is part of that described as follows:

Part of DLC of Peter M. Rinearson & wife in Sec. 19. T 2 S, R 2 E, W.M., described as beg. at a point that is 2324.14 ft. S. & 1640.37 ft. W. of the \(\frac{1}{4} \) sec. corner between sections 18 & 19. T 2 S, R 2 E, W.M., running thence N. 46°37' W. 217.94 ft., thence S. 50°19' W. 997.15 ft. to a point in the meander line of the right bank of the Willamette River; thence following the meander line along the right bank of said River upstream S. 45° E. 296.00 ft; thence with said meander line S. 59°19' E. 43.60 ft; thence N. 43°23' E. 988.63 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
