CERTIFICATE OF WATER RIGHT

This Is to Certify, That C. B. BUCHANAN, JR.

of P. O. Box 523, Cornelius, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualatin River a tributary of Willamette River for the purpose of irrigation under Permit No. 21189 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 18, 1952.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.44 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SW 1/4, NE 1/4 SW 1/4 & SE 1/4 SW 1/4, all as projected within Soloman Emerick DLC #46, Section 3, Township 1 South, Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 3.0 acres in the SW 1/4 NE 1/4
- 9.4 acres in the SE 1/4 NW 1/4
- 4.9 acres in the SW 1/4 NW 1/4
- 31.0 acres in the NE 1/4 SW 1/4
- 19.6 acres in the NW 1/4 SW 1/4
- 6.3 acres in the SW 1/4 SW 1/4
- 24.3 acres in the SE 1/4 SW 1/4
- 8.6 acres in the NW 1/4 SE 1/4
- 8.3 acres in the SW 1/4 SE 1/4

All as projected within Emerick DLC #46
Section 3
Township 1 South, Range 3 West, W.M.

Land on which water is to be used is part of that described as follows: Commencing at the NE cor. of the DLC of Solomon Emerick #46 in T 1 S, R 3 W, W.M., & running thence W. 40 chs; thence S. 40 chs more or less to the S. line of said Emerick claim; thence E. along the S. line thereof to the center of the Tualatin River; thence down the same to the point where the E. line of said DLC crosses said river; thence N. along the said E. line to the place of beg., containing 158.19 acres. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
