the right hereby confirmed dates from September 25,1911; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not

exceed cubic feet per second.

A description of the lands under such right, and to which the water hereby confirmed is appartenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 8.04 acres in Lot One; 3 acres in Lot Two; 8.94 acres in Lot Ten; 8.94 acres in Lot Seventeen; 3 acres in Lot Twenty-seven; 8.63 acres in Lot Twenty-eight, 8 acres in Lot Twenty-nine and 5 acres in Lot Thirty-two, Section Thirty-six, Township Two North, Range Nine East of Willamette Meridian, in Hood River County, Oregon.

The use for irrigation purposes hereunder shall be limited to oneeightieth of one cubic foot per second for each acre irrigated, or its equivalent in case of rotation; balance for domestic use. The use for irrigation purposes shall conform to any reasonable rotation system ordered by the proper State Officer.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
