CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN AMREIN

97/23

of Rt. 2, Box 263, Hillsboro, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualatin River a tributary of Willamette River for the purpose of irrigation under Permit No. 22028 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 11, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Abram Sulgar DLC #61, Section 16, Township 1 South, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per-acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 4.3 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Abram Sulgar DLC #61
 - 1.5 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Abram Sulgar DLC #61
 - 23.4 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Abram Sulgar DLC #61
 - 0.8 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Henry Nowland DLC #67
- Section 16
Township 1 South, Range 2 West, W.M.

Land on which water is to be used is part of that described as follows:

All that portion of that certain tract hereinafter described lying & being situate on the W. side of County Rd. No. 404, Containing 40 acres, more or less, which said tract is described in the deed by J. M. Richards, a single man, to Elmer Scott & May Scott, husband & wife, dated November 15, 1926, & recorded at page 303. Book 134, of the Records of Deeds of Washington County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
