under Permit No. 23184 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 10, 1954

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NEtNEt, as projected within C. McKay DLC #73.

Section 12. Township 1 North, Range 3. West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited per acre of not to exceed 21 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.6 acres in the NEWNEW, as projected within Charles McKay DLC #73
0.3 acres in the NEWNEW, as projected within Birston DLC
Section 12
Township 1 North, Range 3 West, W.M.
Land on which water is to be used is part of that described as follows:

Lots 6 & 7 in Block 54, North Plains, County of Washington, State of Oregon, according to the duly recorded map & plat thereof on file and of record in the office of the county clerk of the said county of Washington.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
