CERTIFICATE OF WATER RIGHT

This Is To Certify, That I. O. WILLIAMSON

of Route 1, Aurora, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Case Creek a tributary of Champoeg Creek, tributary of Willamette River for the purpose of irrigation under Permit No. 18192 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 14, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Gauthers DLC #81, Section 24, Township 4 South, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

20.0 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$
0.1 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$

Both as projected within G. Gauthers DLC #81
Section 24
Township 4 South, Range 2 West, W. M.

Land on which water is to be used is part of that described as follows:

Beg. at a point on the E. line of Barney Kennedy's DLC 7.66 chains North 15° 15' E. from the SE corner of said claim; thence running N. 15° 15' East 11.46 chains to the SW corner of a tract of land conveyed by D. E. Pendleton et al to Cena J. Kinyon by deed recorded in Vol. 88, page 149, Deed Records for Marion County, Oregon; thence Easterly along the Southerly line of said tract 24.96 chs, more or less, to the center of the County Road; thence Southerly along the center of said County Road 14.88 chains to the Southeast corner of the tract of land conveyed to Geo. A. Pendleton to M. E. Pendleton by Deed recorded in Vol. 98, page 271, Deed Records for Marion County, Oregon; thence N. 75° 15' West 23.17 chains to the place of beginning and containing 30.06 acres of land, more or less, and being a part of Peter Gauthier DLC #81 in T 4 S, R 2 W, W. M., Marion County, Oregon save and except all roads and rights of way.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
