CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOSEPH H. SCHULTE

of 10065 S.W. Johnson, Tigard , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Fanno Creek

a tributary of Tualatin River irrigation

for the purpose of

under Permit No. 20296 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the luws of Oregon; that the priority of the right hereby confirmed dates from April 23, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **MainWais** Section 2. Township 2 South. Range 1 West. W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres in the NW1NW4
Section 2
Township 2 South, Range 1 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at the SE cor. of Lot 14 of the Amended Plat of North Tigardville Addition, running thence N. 64° 38' W. along the Southerly line of said Lot 14, 100.0 ft.; thence N. 23° 50' E. parallel with the Easterly line of said Lot 14 135.25 ft.; thence N. 13° 31' W. 134.2 ft. thence continuing N. 13° 31' W. 40 ft. to a point in the center of Fanno Creek; thence down stream following the center of Fanno Creek with all its meanderings thereof in a Westerly, Northerly, Northeasterly & Southeasterly direction 750 ft; more or less, to the NE cor. of said Lot 14; thence S. 23° 50' W. 344.0 ft. to the point of beg.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
